Message from the CEO: AGL Resources Files S-4 with Securities and Exchange Commission

This afternoon, AGL Resources filed a registration statement on Form S-4 with the Securities and Exchange Commission. The Form S-4 is required to register shares of AGL Resources common stock intended to be issued to Nicor shareholders in consideration of the merger. The registration statement includes a joint proxy statement that will be used by AGL Resources and Nicor as each company solicits shareholder approval at its special meeting of shareholders.

The SEC is expected to respond with its initial comments within 30 days of the filing. Once the SEC's review process is complete and the registration statement is declared effective, the dates for the special meetings of shareholders of each company will be set, the proxy statement will be distributed and the approval by the shareholders of each company will be solicited. We anticipate that the AGL Resources shareholder vote results will be announced at our special meeting.

AGL Resources and Nicor also recently filed a joint application with the California Public Utilities Commission to transfer ownership of Central Valley Gas Storage ultimately from Nicor to AGL Resources through a series of proposed transactions. We are seeking the CPUC's approval by early May.

We still expect to close the merger during the second half of 2011. I will keep you informed of our progress and all other important developments.
