(1) The Series A 12.0% Cumulative Senior Preferred Stock automatically converted into Common Stock upon the closing of the initial public offering of TAL International Group Inc.'s Common Stock. The Series A 12.0% Cumulative Senior Preferred Stock had a face value of \$1,000 per share and was converted into Common Stock at a conversion price equal to the initial public offering price of \$18 per share, resulting in a conversion of 125 shares of Series A 12.0% Cumulative Senior Preferred Stock into 6,944 shares of Common Stock.

(2) The options vest in four equal annual installments, beginning with one-fourth on October 11, 2006.
