In its role as investment advisor, or manager, Paulson possesses voting and/or investment power over the securities of the Issuer described in this schedule that are owned by the Funds. All securities reported in this schedule are owned by the Funds. Paulson disclaims beneficial ownership of such securities.

Note 2: As of the date hereof, Paulson may be deemed to be the beneficial owner of 5,834,339 Shares of the Issuer. This number includes (A) 4,850,000 Shares and (B) 984,339 Shares issuable upon the conversion of the 7.5% Mandatory Convertible Subordinated Notes due 2013 and the 7.25% Tangible Equity Units due August 15, 2013 (collectively the "Convertible Securities") beneficially owned by Paulson.

Note 3: As of the date hereof, assuming full conversion of the Convertible Securities beneficially owned by Paulson, Paulson may be deemed to be the beneficial owner of approximately 7.54% of the total number of Shares outstanding.
