This Amendment No. 12 to Schedule 13D (the Statement) relates to the Common Stock, no par value per share (the Common Stock), of Winmark Corporation, a Minnesota corporation (the Company). The principal executive office of the Company is located at 605 Highway 169 N, Suite 400, Minneapolis, MN 55441.

Item 2. Identity and Background.
