Delaware General Corporation Law
The Company is incorporated under the laws of the State of Delaware. Section 145, as the same exists or may hereafter be amended (Section 145), of the General Corporation Law of the State of Delaware (the DGCL) provides that a Delaware corporation may indemnify any persons who were, are or are threatened to be made parties to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative (other than an action by or in the right of such corporation), by reason of the fact that such person is or was a director, officer, employee or agent of another corporation or enterprise. The indemnity may include expenses (including attorneys fees), judgments, fines and amounts paid in settlement actually and reasonably incurred by the person in connection with such action, suit or proceeding, provided such person acted in good faith and in a manner he or she reasonable cause to believe that his or her conduct was unlawful. A Delaware corporation may indemnify any persons who were, are or are threatened to be made a party to any threatened, pending or completed action or suit by or in the right of the corporation by reasons of the fact that such person is or was a director, officer, employee or agent of such corporation, or is or was serving at the request of such corporation as a director, officer, employee or agent of such corporation, or is or was serving at the request of such corporation as a director, officer, employee or agent of another corporation or enterprise. The indemnity may include expenses (including attorneys fees) actually and reasonably incurred by such person in connection with the defense or settlement of such action or suit, provided such person acted in good faith and in a manner he or she reasonably believed to be in or not opposed to the corporation settlement of such action or suit, provided such person acted in good faith and in a manner he or she reasonably believed to be in or not opposed to the corporation is permitted without judicial ap
Certificate of Incorporation and By-laws
The Company s Restated Certificate of Incorporation (the Certificate of Incorporation ), provides that the Company will, to the fullest extent permitted by the provisions of Section 145, as the same may be amended and supplemented, indemnify any and all persons whom the Company has power to indemnify under said section from and against any and all expenses, liabilities, or other matters referred to in or covered by said section. In addition, to the fullest extent permitted by law, the Certificate of Incorporation provides that none of the Company s directors will be personally liable for monetary damages for breach of fiduciary duty as a director.

The Company s Bylaws provide that each person who was or is made a party to, or is threatened to be made a party to, or is involved in any action, suit or proceeding, whether civil, criminal, administrative or investigative (the Proceeding), by reason of the fact that such person (or a person of whom such person is the legal representative), is or was the Company s director or officer or a director or officer of a Reincorporated Predecessor (as defined below) or is or was serving at the Company s request or at the request of a Reincorporated Predecessor as a director or officer of another corporation, or of a partnership, joint venture, trust or other enterprise, including service with respect to employee benefit plans, will be indemnified and held harmless by the Company to the fullest extent permitted by the DGCL, against all expenses, liability and loss (including attorneys fees, judgments, fines, ERISA excise taxes and penalties and amounts paid or to be paid in settlement) reasonably incurred or suffered by such person in connection therewith, provided such person acted in good faith and in a manner which the person reasonably believed to be in or not opposed to the Company s best interests, and, with respect to any criminal action or Proceeding, had no reasonable cause to believe the person s conduct was unlawful. Such indemnification will continue as to a person who has ceased to be a director or officer and will inure to the benefit of such person s heirs, executors and administrators. Notwithstanding the foregoing, the Company will indemnify any such person seeking indemnity in connection with a Proceeding (or part thereof) initiated by such person only if such Proceeding (or part thereof) was authorized by the Company s board of directors. As used in this paragraph, the term the Reincorporated Predecessor means a corporation that is merged with and into the Company in a statutory merger where (a) the Company is the surviving corporation of such merger; and (b) the primary purpose of such merger is to

The Company entered into indemnification agreements with its current directors and executive officers to give those directors and officers additional contractual assurances regarding the scope of the indemnification set forth in the Company s Certificate of Incorporation and Bylaws and to provide additional procedural protections. In addition, the Company maintains directors and officers liability insurance covering some liabilities for actions taken in their capacities as such, including liabilities under the Securities Act.
