- (3) Grantee may elect to pay the exercise price of the option or any tax withholding obligation in connection therewith by directing the Company to withhold a portion of the shares otherwise distributable to the grantee upon exercise or by transmitting to the Company previously acquired shares, valued at their fair market value on such taxable date.
- (4) The option vests in five equal installments beginning July 11, 2012.
