(1) The phantom stock units convert to the common stock's cash value on a one-for-one basis.

The phantom stock units accrue under the Johnson Controls Directors' Deferred Compensation Plan and are to be settled 100% in cash upon the reporting person's retirement. The reporting person has the right to transfer the value of the phantom stock account into an alternative investment account within the plan.

(3) Includes 261.804 phantom stock units acquired via dividend reinvestment on July 2, 2014 at a price of \$50.92 per phantom stock unit.

The phantom stock units were accrued under the Johnson Controls Directors' Retirement Plan and are to be settled 100% in cash upon the reporting person's retirement. The reporting person has the right to transfer the value of the phantom stock account into an alternative investment account within the plan.
