This option was previously reported as an option for 181,840 shares of Class A Common Stock at an exercise price
- (15) of \$612.00 per share, but was adjusted to reflect the Stock Dividend. As a result of adjustment, the option now entitles the Reporting Person to exercise a portion of the option for 181,840 shares of Class C Capital Stock, and the exercise price has been adjusted so that the portion of the option covering Class A Common Stock now has an exercise price of \$306.612 and the portion of the option covering Class C Capital Stock has an exercise price of \$305.388 per share.
- The option provided for vesting as follows: 25% of the option shall vest 12 months after vesting commencement date and 1/48th of (16) shares shall vest each month thereafter until the option is fully vested, subject to continued employment with Google on the applicable vesting dates.
