- (1) McDonald's Corporation (?McDonald's?) disposed of 16,539,967 shares of Class B Common Stock of Chipotle Mexican Grill, Inc. (?Chipotle?) in a registered exchange offer to its shareholders. The final exchange ratio was 1 share of McDonald's Class A Common Stock for 0.8879 shares of Class B Common Stock. As a result of the exchange offer, McDonald's has disposed of its entire equity interest in Chipotle. Prior to the exchange offer, the Class B Common Stock was convertible at any time at the holder's option on a one-for-one basis into Class A Common Stock. In connection with the exchange offer, the Class B Common Stock will become a separate equity security and will no longer be convertible.
