- (1) Mr. Berns did not sell any of the 3,019 reported shares. Rather, this amount represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of withholding taxes due upon the 7/02/11 vesting of 8,333 shares of the 25,000 shares of restricted stock Mr. Berns was granted on 05/18/09. These withheld shares are not sold on the open market and become Revlon, Inc. treasury shares.
- (2) Of the 18,960 shares beneficially owned, 8,334 shares are unvested restricted shares that the reporting person was granted on 05/18/09 which vest on 7/02/12.
