- (1) On October 3, 2013, the Trust established under the Urstadt Biddle Properties Inc. Excess Benefit and Deferred Compensation Plan of 2005 (the "Compensation Plan Trust") (and together with a similar Trust established in 2000, the "Compensation Plan Trusts"), purchased 1,118 shares of Common Stock for the benefit of Willing L. Biddle, the Reporting Person's husband, at prices ranging from \$17.03 to \$17.50 per share, with a weighted average price of \$17.2385 per share.
