(1) Since the reporting persons last report, 2,500 shares held by Stock Award have vested and are now owned directly.

All unvested award shares after the fourth vesting date will be forfeited.

(6) Stock Awards granted pursuant to the SI Financial Group, Inc. 2012 Equity Incentive Plan vest in five equal installments commencing on February 16, 2012.

(7) Stock Awards granted pursuant to the SI Financial Group, Inc. 2012 Equity Incentive Plan vest in five equal installments commencing on October 24, 2013.
