As a result, this Form 4 is a voluntary report with respect to these purchases of the Issuer's common stock by the Foundation.
- (4) The reporting person has sole voting and dispositive power with respect to such shares in his capacity as trustee of the Jack W. Schuler Living Trust.
- (5) The reporting person has sole voting and dispositive power with respect to such shares in his capacity as manager of Schuler Grandchildren LLC.
- (6) The reporting person has shared voting and dispositive power with respect to such shares in his capacity as the grantor of Schuler GC 2010 Continuation Trust.

- (7) The reporting person disclaims beneficial ownership of these securities except to the extent of his pecuniary interest therein, and the inclusion of these shares in this report shall not be deemed an admission of beneficial ownership of all of the reported shares for purposes of Section 16 or for any other purpose.
