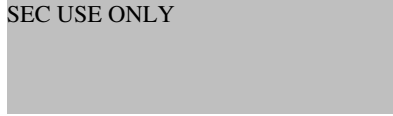

(b) Percent of Class: Of the 8,918,740 shares outstanding as of November 3, 2015 according to the Form 10-Q filed by the issuer with the Securities and Exchange Commission on November 6, 2015, MAML held 7.48% of which Manulife Canadian Focused Fund held directly 6.83%. and MAM (US) held 0.29%.
