The common shares were acquired pursuant to the exercise of stock options with an expiration date of 02/11/09. The Company's earnings

(1) blackout period 01/10/09 to 03/13/09 prohibited Mr. Welton from disposing of IMAX common shares in that period. The stock option plan's blackout provision extended the option expiry to 03/23/09.

(2) The Stock Options became exercisable in three installments of 5,000 each on February 11, 2003; February 11, 2004 and February 11, 2005.
