- (1) Restricted Stock Units vest in three annual installments beginning March 7, 2012. On the settlement date, for each vested RSU, the reporting person received one share of Common Stock. Vesting was also subject to meeting pre-established earning goals.
- (2) Performance Based Restricted Stock Units vest in 3 years. Number of vested units was based on meeting performance criteria. 35,699 units were for the performance maximum if pre-established performance goals are met. On the settlement date, for each vested RSU, the

reporting person received one share of Common Stock.

Performance Based Restricted Stock Units vest in 3 years. Number of units that will vest depends on meeting performance criteria.

- (3) 176,390 units are for the performance maximum if pre-established performance goals are met. On the settlement date, for each vested RSU, the reporting person will receive one share of Common Stock.
