 The securities reported are in the form of restricted stock units (RSUs) issued on June 5, 2006 pursuant to the SeaChange International, Inc. 2005 Equity Compensation and Incentive Plan that entitle the reporting person to receive one (1) share of common stock per RSU.
  - (1) The RSUs will vest, and the underlying common stock will issue, ratably over three years. The first tranche will vest on May 31, 2007, with an equal number of shares vesting on May 31, 2008 and the balance of the shares vesting on May 31, 2009.
  - (2) 33.33% (3,999 shares) vest at the end of the first year (5/31/07) and and additional 8.34% (1,000 shares) at the end of each quarter thereafter.
