Stock units are entitled to dividend equivalent rights, which accrue on dividend record dates.

(3) These stock units will automatically be converted into shares of common stock on the six-month anniversary of the date the Director ceases to be a Member of the Board of Directors of the Company, unless a further deferral election has been made.

(4) Restricted stock units are entitled to dividend equivalent rights, which accrue on dividend record dates.

(5) Phantom stock units are entitled to dividend equivalent rights, which accrue on dividend record dates.

This amount represents the cumulative total of all Restricted Stock Units (deferred stock awards) granted to reporting person.
