- (1) 329 shares were withheld from the 1,000 restricted shares that vested on May 30, 2013. These 329 shares represent the value of the taxes required to be withheld pursuant to applicable employment or tax laws, as determined by the Issuer. These 1,000 restricted shares were awarded to Dr. Burke on May 30, 2012. These vested shares were valued at the NYSE closing market price on May 30, 2013.
- (2) 247 shares were withheld from the 750 restricted shares that vested on May 31, 2013. These 247 shares represent the value of the taxes required to be withheld pursuant to applicable employment or tax laws, as determined by the Issuer. These 750 shares were awarded to Dr. Burke on May 31, 2011 as part of an award of 3,000 restricted shares. These vested shares were valued at the NYSE closing market price on May 31, 2013.
