Unilever NV also announces that 27,411 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 67,411,226 Unilever NV ordinary shares in treasury, and has 1,647,316,474 Unilever NV ordinary shares in issue (excluding treasury shares).
