Unilever NV announces that on 14 March 2008 it purchased 1,364,943 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 20.610 and euro 21.200 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 65 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 146,428,877 Unilever NV ordinary shares in treasury, and has 1,568,298,823 Unilever NV ordinary shares in issue (excluding treasury shares).
