***Response to Gold Fields announcement***

Harmony notes the announcement by Gold Fields on 18 May 2005, claiming that Harmony's offer for Gold Fields is not unconditional in all respects.

Gold Fields' claim is based on an incorrect interpretation of South African competition law.

The Competition Tribunal approved the merger on 10 May 2005. As a result, Harmony's offer became unconditional in all respects.

Under South African competition law, the approval of the merger by the Competition Tribunal remains in place unless it is either suspended or overturned by the Competition Appeal Court, events that Harmony considers to be remote in the extreme. Accordingly, Harmony is entitled to settle any valid acceptances received under the offer.

As stated in its announcement dated 10 May 2005, Harmony's offer of 1.275 Harmony shares for each Gold Fields share will close at 12:00 p.m. (South African time), 6:00 a.m. (New York time), on Friday, 20 May 2005.
