**ChipMOS REPORTS DECEMBER 2007 REVENUE**

**Hsinchu, Taiwan, January 17, 2008** ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of December 2007.

Revenue for the month of December 2007 was NT\$1,893.3 million or US\$58.4 million, a decrease of 8.9% from the month of November 2007 and a decrease of 4.0% from the same period in 2006. On a quarterly basis, revenue for the fourth quarter of 2007 was NT\$6,101.7 million or US\$188.1 million, an increase of 2.7% from the third quarter of 2007 and an increase of 3.1% from the same period in 2006. Revenue for the full year of 2007 was NT\$23,597.6 million or US\$727.6 million, an increase of 15.8% compared to 2006. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$32.43 against US\$1.00 as of December 31, 2007.)
