Item 5 of this Schedule 13D is amended to add the following:

(a)-(b) Mr. Buffett owns, and has the sole power to vote and to dispose of, 350,000 shares of Class A Common Stock and 2,020,268 shares of Class B Common Stock, representing approximately 32.62% of the outstanding shares of Class A Common Stock, 14.14% of the outstanding shares of Class B Common Stock, 31.46% of the aggregate voting power of the outstanding shares of both classes, and 26.94% of the economic interest of the outstanding shares of both classes.

(c) On July 1, 2008, Mr. Buffett donated 451,250 shares of Class B Common Stock to the Bill and Melinda Gates Foundation pursuant to his previously announced irrevocable pledge to this foundation.

On July 1, 2008, Mr. Buffett donated 45,125 shares of Class B Common Stock to the Susan Thompson Buffett Foundation pursuant to his previously announced irrevocable pledge to this foundation.

On July 1, 2008, Mr. Buffett donated 15,794 shares of Class B Common Stock to each of the Susan A. Buffett Foundation, the Howard G. Buffett Foundation and the NoVo Foundation pursuant to his previously announced irrevocable pledges to these foundations.
