1. Are the four passes for registered guests one-way or round-trip?

Registered companions are eligible for four allotment tickets, which may include any trip one-way, round trip, etc., and may include as many as eight segments. The allotment ticket is considered complete once the passenger completes eight segments, or once he or she returns to their departure city whichever comes first.

2. Can American employees check in for US Airways flights online somehow, or does it need to be at the airport?

American employees will be able to check in at either the US Airways ticket counter or kiosks up to four hours prior to scheduled departure times.

3. Will the new American recognize my domestic partner?

Both American and US Airways provide benefits for same-sex domestic partners of employees, and we don t see that changing for the new American.
