**Summary**

Today, AMR filed an amended Form S-4 registration statement with the Securities and Exchange Commission (SEC) in connection with its planned merger with U.S. Airways.

This is a routine step in the process called the SEC Review and Comment phase and is common in mergers, including those in the airline industry.

**Key Points**

As a reminder, AMR filed its preliminary Form S-4 on April 15. The Form S-4 provides an explanation of the reasons that the Boards of Directors of AMR and US Airways approved our proposed merger, including expected cost and revenue synergies and the benefits of an expanded network.

As is typical, the SEC reviewed the initial registration statement and responded to the company with comments. The company and its advisors are responsible for addressing each of the comments. The amended registration statement filed today addresses the comments.

The SEC Review and Comment phase allows the SEC to:

Obtain additional information so it can better understand the details in the company's S-4

Provide input where the S-4 could include additional information or clarification

The review and comment process will continue until the SEC is satisfied with the level of detail and supporting information in the S-4.

Once this phase is complete and the SEC declares the Form S-4 effective, US Airways stockholders will be provided the proxy statement/prospectus (part of the S-4) to review and will be asked to vote their shares to adopt the merger agreement and approve the merger at the US Airways 2013 annual meeting, which will be held this summer.
