U.S.-Based Agents, Reps and Planners,

I want to thank you for taking time to participate in the ARP survey. The feedback we received will be valuable as we determine the pay and benefits adjustments we will put in place for your workgroups when the merger closes and we exit restructuring.

We heard from approximately 54 percent of you across the Agent, Representative and Planner workgroups - a great response rate for internal surveys - and your participation helped us identify what matters most to you. You also provided great feedback in the open text section, which we plan to look at carefully over the next few weeks.

I know many of you are anxious for a final decision to be announced, so I wanted to explain the next steps in the process. Once we have analyzed the results of the survey, we will discuss our findings with the leadership at US Airways to jointly determine the adjustments we will implement for American's Agents, Reps and Planners. Since these changes will be tied to the merger closing and will have implications for the new American and the finances of the merged company, we have an obligation to partner with US Airways to make these decisions. This is the same process we followed with the MOUs that were put in place for the unionized groups. When we have a final determination, we will share the changes with all of you.

Thank you for your participation, and I look forward to sharing more details with you soon.
