**Item 8.01 Other Events**

On June 6, 2013, PowerSecure International, Inc., a Delaware corporation (the Company), issued a press release announcing that it has added approximately \$75 million to its revenue backlog, including approximately \$49 million from a renewed and expanded three year utility infrastructure (UI) award to serve one of the nation's largest investor owned utilities. In addition, the new business awards include approximately \$18 million of new distributed generation business, approximately \$4 million of additional new UI business, and approximately \$4 million in new energy efficiency sales.
