AIG Asset Management (U.S.), LLC, American General Life Insurance Company and American Home Assurance Company, each an indirect wholly owned subsidiary of AIG, beneficially own 35.0%, 23.3% and 11.7%, respectively, of the Mandatory Redeemable Preferred Shares.
