- (1) Represents Common Stock awarded to the employee. Disposition of shares to the issuer in the form of share withholding pursuant to the eLoyalty Corporation 2006/2007 Salary Replacement Program and the 1999 Stock Incentive Plan to satisfy tax withholding obligations. The disposition was approved by the Compensation Committee in accordance with Rule 16b-3.
- (3) Award of time-vesting restricted stock pursuant to eLoyalty Corporation 1999 Stock Incentive Plan, subject to continuing employment. The Award was approved by the Board of Directors of the issuer for purposes of 16b-3 and includes a tax withholding feature. 6,167 shares will vest on 2/29/2008. 15,000 shares have the following vesting schedule: 25% will vest on 2/28/2009 and 6.25% will vest each quarter until fully vested.
