(1) On March 3, 2008, the pre-paid variable share forward arrangement (the "Transaction"), which Dr. Robb had entered into on March 2, 2007 with an unrelated third party (the "Buyer") relating to 50,000 shares of common stock of Celgene Corporation ("Common Stock"), matured. Pursuant to the terms of the Transaction, because the settlement price (\$56.30) was higher than the forward floor price (\$52.33), based on a predetermined formula, Dr. Robb will deliver 46,474 shares of Common Stock to the Buyer on March 6, 2008, which shares had been previously pledged to the Buyer to secure his obligations under the Transaction.
