- (1) On July 16, 2008, the common stock of Fluor Corporation split 2-for-1, resulting in the reporting person's ownership of 4,180.4147 additional shares of stock.

- (3) These restricted stock units were adjusted to reflect the company's 2-for-1 stock split which occurred on July 18, 2008.
- (4) The restricted stock units vest in five equal annual installments beginning on May 7, 2004.
- (5) The restricted stock units vest in five equal annual installments beginning on May 7, 2005.
- (6) The restricted stock units vest in five equal annual installments beginning on May 3, 2006.
