  - (1) Represents award of restricted stock units ("RSUs") that will vest 25% annually over four years, subject to Mr. Hoppenot's continued service with the Issuer through the applicable vesting dates. The RSUs may be settled only for shares of common stock on a one-for-one basis.
  - (2) Includes an aggregate of 289,701 shares of common stock issuable pursuant to previously reported restricted stock units that have not vested.
  - (3) Beginning July 15, 2016, options become exercisable in 37 installments, with the first 25% vesting after one year and the remainder vesting monthly over three years.
