On July 15, 2018, the Reporting Person was awarded an aggregate total of 1,773 restricted share units (RSUs) pursuant to the terms of the Issuer's Share Election Program as approved by Issuer's Board of Directors and Shareholders on 7/24/2013 and 7/29/2013, respectively.
