- (1) The restricted stock units (the "RSU") convert into Issuer's Common Stock on a one-for-one basis.

- (5) The RSU shall vest in two equal installments, at a rate of 1/2 of the RSU on March 1, 2019 and 1/2 of the RSU on September 1, 2019 for so long as the Reporting Person provides continuous service to the Issuer, such that the RSU shall be fully vested on September 1, 2019.
