(1) Includes 137 shares acquired under the Equinix, Inc. Employee Stock Purchase Plan on February 12, 2016.

(2) On February 12, 2015 the reporting person was granted performance restricted stock units, the vesting of which was subject to both continued service and the attainment of certain revenue and AFFO targets for 2015. The Compensation Committee certified the degree to which the targets were achieved, therefore 50% of the award vested on February 12, 2016, with 25% additional units scheduled to vest on each of February 15, 2017 and February 15, 2018, subject solely to continued service.

(3) On February 11, 2016, the reporting person was granted restricted stock units, the vesting of which is subject solely to continued service through each vesting date. 33.33% of the award is scheduled to vest on January 15, 2017, with an additional 33.33% units scheduled to vest on each of January 15, 2018 and January 15, 2019.

(4) Restricted stock unit award expires upon reporting person's termination of employment.
