NOTICE TO THE MARKET

Complimenting the Material Fact published on August 28 concerning FINANCEIRA ITAÚ CBD S.A. (FIC), Companhia Brasileira de Distribuição hereby announces that, according to its estimates, the renegotiation of the agreement with Itaú will result in certain positive impacts for the Company, including:

- An estimated increase of R\$ 50 million per year in financial revenues from the investment of the additional cash resulting from the entry of the resources resulting from the operation.
- Potential savings of R\$ 75 million in 2009 from the elimination of the performance clauses from the original agreement, which could have resulted in disbursements if certain performance targets were not met.
- An estimated R\$ 40 million per year increase in net revenues from the extended warranties service, given that the new agreement returns the management and sale of this product to CBD.

We should emphasize that the above-mentioned figures are management estimates based on its assumptions and on information currently available to the Company.
