**Brazilian President Signs Bill for Transfer of  
Rights with Compensation and Capitalization**

Rio de Janeiro, June 30, 2010   Petróleo Brasileiro S.A. - Petrobras, informs that today Draft Bill No. 5.941/09 concerning the transfer of rights with compensation ( transfer of rights ) and the capitalization of Petrobras was signed into law by the President of the Republic, having previously been approved by the Brazilian National Congress on June 9, 2010.

The new law authorizes the Brazilian Federal Government to transfer to Petrobras the right to explore and produce oil, natural gas and other fluid hydrocarbons in pre-salt areas not under concession, limited to the production of 5 billion barrels of oil equivalent, in addition to authorizing the Brazilian Federal Government to subscribe for shares of the capital stock of Petrobras.

The President of the Republic vetoed a provision of the Bill approved by the Brazilian National Congress (Article 1, Section 4) that would have allowed Petrobras to pay for the transfer of rights by returning certain onshore fields to the ANP that are currently under concession to Petrobras.

With the President's signature of the Bill, another important step in the process of the transfer of rights and the Company's capitalization is fulfilled. Petrobras expects to complete the capitalization by September of this year.

This announcement is not an offer of Petrobras shares. Petrobras shares may not be offered or sold in the United States absent registration or an exemption from registration, and Petrobras currently intends to register the proposed offering in the United States. Any public offering of Petrobras shares will be made by means of a prospectus containing detailed information about Petrobras and the offering.
