### **Clarification on the Port of Itaguaí**

Rio de Janeiro, March 17<sup>th</sup>, 2011   Petróleo Brasileiro S.A.   Petrobras, in response to Brazilian Exchange Commission (CVM) request and regarding the article published in *Jornal Valor Econômico* on March 16<sup>th</sup>, 2011, titled "Petrobras, CSN and Gerdau reach deal on Itaguaí", hereby clarifies the following.

On July 7<sup>th</sup>, 2009, the Company informed the market about the signing of a Memorandum of Understanding (MOU) with Gerdau S.A and Companhia Siderúrgica Nacional (CSN) in order to study the possibility of jointly executing a port facilities development project in Sepetiba Bay.

The Company continues to perform studies along with CSN and Gerdau with the intent of developing the project mentioned above so that the interests of the three companies are met.
