- II. **Approval:** Nomination of the Advisory Committees of CPFL Energia's Board of Directors;
- III. **Approval:** Election of CPFL Energia's Board of Officers and designation of the Subsidiaries' Board members;
- IV. **Vote Recommendation:** Contracting of services of construction, expansion and renewal of substations (turn-key contracts), by the subsidiaries CPFL Paulista, CPFL Santa Cruz and RGE;
- V. **Vote Recommendation:** Acquisition of energy in the new energy auction, for delivery as of 2014, by the subsidiaries CPFL Paulista, CPFL Piratininga, RGE, CPFL Santa Cruz, CPFL Leste Paulista, CPFL Sul Paulista, CPFL Jaguari and CPFL Mococa;
- VI. Other matters unrelated to CVM Instruction 358/2002, as amended.
