UPDATE ON INSIDER SHARE OWNERSHIP**

**ATHENS, GREECE, September 19 2012** Star Bulk Carriers Corp. (the Company or Star Bulk ) (Nasdaq: SBLK), a global shipping company focusing on the transportation of dry bulk cargoes, today announced that Mr. Petros Pappas, Chairman of the board of directors of the Company, transferred all of the common shares of the Company that he beneficially owned to his two children for estate planning purposes. Ms. Milena Pappas, a Class B director of the Company and the daughter of Mr. Petros Pappas, and Mr. Alexandros Pappas, the son of Mr. Petros Pappas, each received 3,008,636 restricted common shares representing approximately 3.7% of the Company's outstanding common shares.

Mr. Petros Pappas plans to file an amended Schedule 13G with the Securities and Exchange Commission to report that he no longer beneficially owns any common shares of the Company.

**About Star Bulk**

Star Bulk is a global shipping company providing worldwide seaborne transportation solutions in the dry bulk sector. Star Bulk's vessels transport major bulks, which include iron ore, coal and grain and minor bulks such as bauxite, fertilizers and steel products. Star Bulk was incorporated in the Marshall Islands on December 13, 2006 and maintains executive offices in Athens, Greece. Its common stock trades on the Nasdaq Global Market under the symbol SBLK. Currently, Star Bulk has an operating fleet of fourteen dry bulk carriers consisting of six Capesize and eight Supramax dry bulk vessels with a combined cargo carrying capacity of 1,475,005 deadweight tons. The average age of our current operating fleet is approximately 10.5 years.
