- (1) The sale was made pursuant to a Rule 10b5-1 Sales Plan adopted by the Reporting Person on June 11, 2013.  
The 20,000 shares were sold in 24 lots ranging from 16 shares to 2,800 shares per lot. The sale price ranged between \$32.36 and \$32.65.
- (2) The price reported above represents the weighted average sale price. - (4) Subject to the Reporting Person's continuing employment and the provisions in the Altera's standard form of stock option agreement, the options shall commence vesting at 25% of the shares on the first anniversary of the grant date and monthly thereafter such that the option will be fully vested four years after the grant date.
