- (1) The 40,000 shares were sold in 69 lots ranging from 100 shares to 4,600 shares per lot. The sale price ranged between \$33.646 and \$33.93. The price reported above represents the weighted average sale price. - (2) The per share exercise price for the Shares to be issued pursuant to exercise of an option shall be no less than 100% of the Fair Market Value per share on the date of Grant.
- (3) Subject to the Reporting Person's continuing employment and the provisions in the Altera's standard form of stock option agreement, the options shall commence vesting at 25% of the shares on the first anniversary of the grant date and monthly thereafter such that the option will be fully vested four years after the grant date.
