This Registration Statement on Form S-8 is being filed by KLA-Tencor Corporation (the "Registrant") with the Securities and Exchange Commission (the "Commission") for the purpose of registering an additional 2,000,000 shares of the Registrant's common stock, par value \$0.001 per share, for issuance pursuant to the Registrant's Amended and Restated 1997 Employee Stock Purchase Plan. In accordance with General Instruction E to Form S-8, the contents of Registration Statement No. 333-198006, filed with Commission on August 8, 2014, are incorporated herein by reference.
