(the "Company") entered into an Underwriting Agreement for the sale of \$250,000,000 aggregate principal amount of its First Mortgage Bonds, 3.10% Series due July 1, 2023 (the "Bonds"). The Bonds were registered under the Securities Act of 1933, as amended, by means of the Company's Post-Effective Amendment No. 2 to the automatic shelf Registration Statement on Form S-3 (File No. 333-169315-07), which became effective upon filing on March 4, 2011.
