Item 2.02 Results of Operations and Financial Condition

On February 8, 2006, National Fuel Gas Company (the Company) issued a press release regarding its earnings for the quarter ended December 31, 2005. A copy of the press release is hereby incorporated by reference into this Item 2.02 and furnished as part of this Current Report as Exhibit 99.

The Company believes that such non-GAAP financial measures are useful to investors because they provide an alternative method for assessing the Company s operating results in a manner that is focused on the performance of the Company s ongoing operations. The Company s management uses these non-GAAP financial measures for the same purpose, and for planning and forecasting purposes. The presentation of non-GAAP financial measures is not meant to be considered a substitute for financial measures prepared in accordance with GAAP.
