PPG's 2015 Annual Meeting of Shareholders will be conducted on Thursday, April 16 at the Fairmont Pittsburgh.

Employees who were PPG shareholders on Feb. 20, 2015 should have received a notice (by mail or e-mail) providing detailed voting instructions and the manner for accessing the proxy materials for the annual meeting.

As indicated in the proxy materials, PPG's Board of Directors recommends that shareholders vote as follows:

• Proposal 1: FOR the election of four directors (Charles E. Bunch, Michael W. Lamach, Martin H. Richenhagen and Thomas J. Usher), each for a term of three years;

• Proposal 2: FOR the approval of the compensation of PPG's named executive officers;

• Proposal 3: FOR an amendment to PPG's Articles of Incorporation to replace the supermajority voting requirements; and

• Proposal 4: FOR the ratification of PricewaterhouseCoopers LLP as PPG's independent registered public accounting firm for 2015.

"Shareholders have a valuable opportunity to vote on these important proposals," said Anne Foulkes, assistant general counsel and secretary. "We encourage all shareholders to read the proxy materials and to exercise their right to vote."
