With respect to its Form 10-K for the fiscal year
ended January 31, 2003

The registrant anticipates that its results of operations for the fiscal year ended January 31, 2003 ("Fiscal 2003") as reflected in its statements of operations to be included in its Form 10-K for the fiscal year ended January 31, 2003 will reflect an increase in net revenue to \$156,783,000 compared to \$101,402,000 for the fiscal year ended January 31, 2002 ("Fiscal 2002"). In addition, the registrant expects to report a loss from operations of \$961,000 in Fiscal 2003 compared to a loss from operations of \$1,545,000 in Fiscal 2002. Net loss for Fiscal 2003 is expected to be \$3,945,000 compared to a net loss of \$2,282,000 in Fiscal 2002. The registrant's Fiscal 2003 results include the results of Unzipped Apparel, LLC since May 1, 2002.
