This Amendment No. 28 to the undersigned's amended Schedule 13G (the "Schedule 13G"), with regard to The Marcus Corporation, is being filed on behalf of the undersigned to amend Item 4 of the originally filed Schedule 13G. Except as expressly stated herein, there have been no material changes in the information set forth in the Schedule 13G.

**Item 4. Ownership:**

**Diane Marcus Gershowitz**

- (b) Percent of Class: 13.4%
- (c) Number of shares as to which such person has:
  - (i) sole power to vote or to direct the vote: 3,042,861
  - (ii) shared power to vote or to direct the vote: 1,023,696

Other than with respect to (i) 7,273 shares of Common Stock (which Ms. Gershowitz has sole voting and dispositive power), (ii) 52,479 shares of Common Stock (which Ms. Gershowitz has sole voting and dispositive power), and (iii) 700 shares of Common Stock (which Ms. Gershowitz shares dispositive power), all of the reported beneficial ownership of Common Stock results from the beneficial ownership of shares of Class B Common Stock, which are convertible at any time into Common Stock on a share-for-share basis. The percent of class figure assumes conversion of all outstanding shares of Class B Common Stock into shares of Common Stock.

Ms. Gershowitz's beneficial ownership consists of:

- (i) 7,273 shares of Common Stock which Ms. Gershowitz has the right to acquire upon the exercise of stock options;
- (ii) 52,479 shares of Common Stock held individually by Ms. Gershowitz;
- (iii) 700 shares of Common Stock held by a trust whereby Ms. Gershowitz and her brother, Stephen H. Marcus, serve as Co-Trustees;
- (iv) 161,699 shares of Class B Common Stock held individually by Ms. Gershowitz;

- (v) 2,821,410 shares of Class B Common Stock held by DG-LDJ Holdings, L.L.C., of which Ms. Gershowitz holds 100% of the membership units;
- (vi) 972,851 shares of Class B Common Stock held by trusts whereby Ms. Gershowitz serves as Trustee;
- (vii) 50,845 shares of Class B Common Stock held by the Ben and Celia Marcus Revocable Trust F/B/O Diane Marcus Gershowitz; and
- (viii) 21,476 shares of Class B Common Stock held by trusts whereby Ms. Gershowitz and her brother, Stephen H. Marcus, serve as Co-Trustees.

The trusts and Ms. Gershowitz, for shares held individually, each have the right to receive dividends and proceeds from the sale of securities held thereby.

**AGREEMENT**

AGREEMENT dated as of February 14, 2007, by and between Diane Marcus Gershowitz and DG-LDJ Holdings, L.L.C., a Delaware limited liability company ( DG-LDJ ).
