The Reporting Person is the managing member of Tontine Management, L.L.C. ("TM"), a Delaware limited liability company, the general partner of Tontine Partners, L.P. ("TP"), a Delaware limited partnership, a Cayman Islands partnership. The Reporting Person is also the managing member of Tontine Overseas Associates, L.L.C., a Delaware limited liability company ("TOA"), the investment adviser to Tontine Overseas Fund Ltd., a Cayman Islands Corporation ("TO"), Tontine 25 Overseas Master Fund, L.P. ("T25"), and certain separately managed accounts.

(1) The Reporting Person directly owns 0 shares of the Common Stock. TM and TOA directly own 0 shares of Common Stock. TP directly owns 6,720,400 shares of Common Stock. TO owns 3,666,485 shares of Common Stock. T25 directly owns 200,000 shares of Common Stock. The separately managed accounts directly own 160,650 shares of Common Stock.
